Candidates are encouraged to submit a one-page résumé outlining their experience and qualifications. All Declarations of Candidacy will remain confidential until the official list of candidates is published on or before **August 14, 2026**.

CANDIDATE ELIGIBILITY:

Candidates must meet the eligibility requirements established in the Judo Ontario Bylaws and Election Policy.

- All directors must be at least 18 years of age at the time of election.
- All directors must be registered members of Judo Ontario
- Be a member in good standing of Judo Ontario.
- The President, Secretary General, Vice-President Technical and Vice-President Competitions must be Black Belt Members (hold a Yudansha rank)
