#### Vision


To be the leader in Canadian judo by increasing our membership, improving our membership services and dominating competitively on the national and international scene.

### **President's Report**

#### Submitted by Aartje Sheffield

It has been a successful and exciting 2018-19 season. Optimization of funding opportunities and solid financial management, with the help of VP Finance, Heather West, has left Judo Ontario in a strong financial position. Judo Ontario received the Province of Ontario's Sport Hosting Grant to run the 2018 Ontario Open, and will receive the grant for a second time to support the 2019 Ontario Open.

For the first time, Judo Ontario has welcomed Humber College Sport Management Interns who have supported our marketing and administration efforts. Additionally, Judo Ontario has again been the recipient of the Summer Experience Program Grant, which has provided the office with administrative support.

Additionally, in 2019 Judo Ontario joined forces with the Canadian Association for the Advancement of Women in Sport and Physical Activity (CAAWS). A recent planning meeting with CAAWS has provided Judo Ontario with some direction toward attaining gender equity in all areas of judo. Among other initiatives, the Terms of Reference for all Judo Ontario committees will begin to include a gender equity target of 60/40 for committee members.

Furthermore, to simplify processes for coaches and volunteers and to provide security to our customers, Judo Ontario has begun using Sterling BackCheck as the preferred criminal record check platform. Sterling Backcheck is simple and inexpensive, and is the same platform used by Judo Canada and the Coaches Association of Canada among dozens of other provincial and national organizations. Dojo Shus, referees, board members and volunteers will be required to complete the Sterling BackCheck.

Some key accomplishments of the Organization and/or its members that I would like to highlight include the following:

- The 2018 Ontario Open was a huge success, running on five mat areas at the Toronto Pan Am Sport Centre (TPASC).
- Judo Ontario has once again been successful in attaining Ontario High Performance Sport Initiative (OHPSI) funding.
- The Judo Ontario Youth Academy and Junior Talent Development Camps continue to be a huge success.
- Judo Ontario Veterans' Trainings were well supported by various GTA clubs.
- Ongoing Monthly Open Mat Training and Provincial Team Trainings.
- Increased programming in the U8-U10 age groups by offering Judo Festivals.
- The Women's Referee Development Initiative has increased the participation of women in refereeing.
- Quarterly Women's Training and All Day Mini-Camp for women and girls have been well received.
- Keagan Young won a bronze medal in the Youth Olympics and Rachel Krapman won bronze in the Youth Olympics Team Event.

- Four Ontario Kata athletes have been selected to compete in the 2019 World Kata Championships (Shane Rooney/Bailey Hu and Raj Venugopal/Allyn Takahashi.)
- Five Ontario Cadets have been selected to compete in the 2019 Cadet World Championships in Almaty, Kazakhstan (- 60kg Daniel McCristall - Upper Canada Judo Club, -70kg Alexandria Lefort - Sheffield Judo Club, +70kg Asia Douglas -Toronto Judo Kai, -90kg Amr Abd Elrehim, +90kg Simon Popov - Toronto Judo Kai)
- Two Ontario Jr. athletes have been selected to compete in the 2019 Jr. World Championships in Marrakesh, Morocco (-81kg Keagan Young Ajax Budokan and -90kg Benjamin Kendrick Takahashi Dojo)
- Three Ontario Sr. athletes have been selected to compete in the 2019 Sr. World Championships in Tokyo, Japan (-57kg Jessica Klimkait Ajax Budokan -70kg Kelita Zupancic Formokan, -100kg Shady El Nahas JCCC Judo Kai)

Judo Ontario will continue to rely heavily on membership revenue, base funding, and grants from our partners to continue improving the reach of our programs. I am very proud of the relationships that we have established with our partners: Judo Canada, the Ministry of Tourism, Culture and Sport and the Canadian Sport Institute of Ontario. I see these relationships as key drivers for success in the years to come. Our sponsorship partners have also been important for the development of Judo Ontario programs and we hope to expand to include even more partnerships.

The 2019 Ontario Open will again see the tournament run on five full mat areas at TPASC and will once again include a Newaza competition and a National A ranked kata competition that will be run in cooperation with Judo Canada's National Grading and Kata Committee. As always, Judo Ontario is appreciative of our volunteers and welcomes those who are interested in helping at the tournament or elsewhere in the organization.

I would like to acknowledge the Committee Chairs, Committee members and the members of the Judo Ontario Board of Directors for their enduring dedication, and professionalism. Parting best wishes and sincere thanks to Jeff Butler (VP Competition), I wish him continued success in his next endeavor. Recognition also goes to the Judo Ontario staff, Leandro Cunha, James Millar, and Steve Sheffield who work tirelessly to make this organization run smoothly and professionally. Thank you to the Judo Ontario membership for allowing me to serve you as President for the past five years. Together there is no limit to what we can achieve.

### 1<sup>st</sup> Vice President's Report

I'd like to thank all the other Board Members and Committee Chairs for their hard work and dedication throughout the year. I'd especially like to acknowledge Jeff Butler's contributions over his tenure as Vice President (Competitions). He leaves a big hole to fill, but we wish him all the best.

#### New Membership Growth Program

One new club has been encouraged to register under the New Membership Growth Program. The program is being adjusted to lower the threshold before existing clubs can be eligible for reimbursements. We are also considering including incentives for growing our female membership base.

#### New Membership System and Website

Judo Ontario has retired our own online membership registration in favour of the Trackie system that Judo Canada and all the other provinces have started using as of last season. A new website is also on the way, thanks to the efforts of James Millar who put together most of the replacement site.

### **Finance Report**

#### Submitted by Heather West

The financial position of the organization continues to be strong thereby allowing us the opportunity to invest in our athletes, organization and equipment. We continue to have success with Grants such as the Sport Hosting Grant for the Ontario Open for this fiscal and next, 3-year Coaching Grant to offset expense of our coaches as well as our ongoing base funding. At this point we have two years of audited statements which can avail Judo Ontario to additional grant opportunities for the organization.

Judo Ontario continues to have a strong cash position with approximately \$277K at the end of the fiscal compared to prior years \$275K. This past year has resulted in a significant decrease in Excess of Revenues over Expenses to \$38K versus prior year \$141K.

One of the most significant factors to account for the decrease of \$103K in Revenue over Expenses are last year's donation from Mr. Ken Morley \$75K. Other revenue generating factors contributing to this are the increase in revenue programs of approximately \$40K mainly registration fees which are recorded in accordance with Generally Accepted Accounting Policies (GAAP). This does not directly align with the membership numbers.

With respect to expenses our athlete development expenses are up approximately \$34K which is representative of more athletes traveling to National and International tournaments, increased Grading Board activities and our Athlete Ambassador program.

Our Athlete Ambassador Program is to provide financial support to Judo Ontario's Nationally carded athletes, thereby encouraging them to continue to compete as Judo Ontario athletes. The program is reviewed annually by the board.

### **Administration Report**

#### Submitted by Susan Sokol

The Judo Ontario board conducted regular meetings and when needed emergency meetings to deal with any specific issues or concerns. The Board worked very hard on a number of initiatives as well as visioning and planning for continued growth and development of Judo in Ontario.

The Awards and Recognition Committee updated the Policy for 2019 with the addition of Kata Athlete award winners.

In the past year Carline Young and I have been heavily involved with CAAWS, Canadian Association for the Advancement of Women in Sport and Physical Activity, as representatives of Judo Ontario as we work to develop a Gender Equity Policy as well as seeking to grow and maintain involvement of women in the various aspects and levels of Judo.

### **Operations Report**

The 2018/2019 Season, a criminal background check service, MyBackcheck, was incorporated. This is a great service that streamlines the process of receiving and maintaining criminal background checks for members. All dojoshus, instructors, referee and board members are encouraged to use this service. Notifications were sent out, and members are starting to get their checks done through MyBackcheck.

As for membership numbers, we still have a challenge getting all judokas registered with Judo Ontario. A Membership growth incentive plan was incorporated to encourage new clubs to register and existing clubs to increase their membership. The position for Dispute and Resolution Member was vacant. I would like to thank our sport partners: Sport Consultant Scott Cooper and the Ministry of Tourism, Culture and Sport, High Performance Athlete Development Advisor James Brough and the Canadian Sport Institute Ontario, and Nicolas Gill CEO/High Performance Director of Judo Canada. ### **Quest for Gold Report**

#### Submitted by Brian Kalsen

Quest for Gold – Ontario Athlete Assistance Program 2018-2019 (OAAP) is funded by the Government of Ontario, through the Ministry of Tourism, Culture and Sport (MTCS), and operated through the Sport, Recreation & Community Programs Division. The overarching goal of the Quest for Gold – OAAP is directly related to the High Performance Sport goal of the Canadian Sport Policy – that Canadians are systematically achieving world-class results at the highest levels of international competition – by improving the performance and number of Ontario athletes performing at the national and international level, thereby contributing to the improved performance of Canada at international competitions.

#### Specific objectives of the program are:

- To help athletes continue their pursuit of athletic excellence at the highest levels of national and international competition;
- To encourage athletes to stay in Ontario to live and train;
- To compensate athletes for earnings lost while training;
- To enable athletes to successfully pursue excellence in sport while fulfilling their educational goals;
- To increase athlete access to improved high performance coaching; and
- To enhance training and competitive opportunities available to athletes.

The program provided direct financial assistance to Ontario junior-aged athletes through an "Ontario Card" designation. "Junior-aged athlete" is defined as those athletes who fall within the eligible age range for the Canada Games - 11 to 22 years of age. (Consideration was given to older junior-aged athletes if a PSO/MSO's NSO-approved Long Term Athlete Development model (LTAD) identifies older athletes in the "Train to Train" and "Train to Compete" categories). The intent of the OAAP is to provide funding to individual athletes based on their demonstrated commitment to high performance sport, allowing them to pursue athletic excellence at the highest levels of national and international competition.

In accordance with the OAAP guidelines, Judo Ontario develops sport-specific selection criteria and forms a Selection Committee that will apply these criteria. The top-ranked athletes, based on the criteria, will be awarded Ontario Card status in 2018-2019. This Selection Criteria has been approved by the Board of Directors and reviewed by MTCS staff. Nominated athletes will be required to sign and comply with an Athlete Agreement between the athlete and Judo Ontario.

### **Competitions Report**

Once again, the Ontario Open and Ontario Youth International both went well and showing an increase in attendance over the previous year. As before, we may have to consider a larger venue for the Ontario Youth, but cost and space availability are always an issue.

The Ontario open had 5 mat areas for 2018 and we would like to be able to incorporate a 6<sup>th</sup> mat area for 2019 but space may be too limited. Ontario Open 2018 saw a couple of incidents that detracted from the tournament. We have been working to hopefully avoid these kinds of problems in the future. It is a challenging time whereby standards and rules must be assessed and changed to reflect modern social interaction. Perhaps it is time to seriously look at the standard Judo tournament format to see if there might be a "better way"? The Ontario Open 2019 will be even better.

The All Community Games tournament was not held this year due to lack of enthusiasm on the part of the ACG committee.

Pre meetings with the Ministry of Tourism regarding the next Ontario Winter Games have begun. Problems and challenges that were part of the 2018 games were addressed and hopefully will be overcome for the next event.

The number of sanctioned tournaments remains low. The extreme cost and logistical problems of running an event are beyond most clubs in Ontario. Also, the necessity of keeping up with socio/legal changes such as "Rowans Law" and Gender Equity as well as rule changes from Judo Canada and IJF present a formidable obstacle to the running of an event. This year the addition of Kata only tournaments and Ne Waza tournament have required the redefinition of tournaments.

Judo Ontario now has some very sophisticated tournament equipment from mats to computers and software. In order to use this equipment effectively it is necessary that the clubs learn how to care and use this equipment.

Some competitions challenges for the next year:

- Training in the setup and use of tournament equipment and Software
- Mat system for efficient setup and ease of use with safety
- Professional use of online data capture for tournaments and competitors
- Enabling clubs from all regions of Ontario to enter the tournament arena.

### **Referee Report**

Over this past 2018 -19 season, Judo Ontario Referees and the Referee Committee have been very busy with a number of activities within Ontario and outside of the province. It was filled with some good news and some sad.

In December, Jim Martin passed away suddenly. Jim was a National A level referee and a great supporter of Judo not only in Ontario but in the rest of Canada and the US. In May at the annual AmCan tournament in New York, the tournament organization recognized Jim with the Dr. Ashida award for contribution to Judo. I accepted the award on his behalf and later presented it to his wife Diane in Lindsay.

The JORC recognizes Jim's dedication and contributions to Judo and to refereeing. He will be missed by all.

Each year, Judo Ontario presents two awards specifically for Judo Ontario referees.

The Tom Kasprzyk Outstanding Referee Contribution Award: This is presented to a Judo Ontario Referee of any level whose outstanding contribution exemplified some or all the following: performance, participation, dependability, perseverance, mentoring and innovation. It is voted on my any Judo Ontario National C level and above referee. This year's recipient is Aartje Sheffield.

Aartje is a member of the JORC and has worked hard to raise awareness of refereeing and to recruit younger judoka especially active and past competitive judoka. Aartje was successful in increasing the number of Judo Ontario women referees. She organized a woman's clinic at the Ontario Open which was facilitated by Brian Fujimoto from the Judo Canada National Referee Committee. It was well attended by over twenty women whose referee experience ranged from novice to veteran. Aartje is organizing another such clinic at this year's event.

As well, Aartje organized trips for the women referees to officiate at the La Coupe Daniel Hardy and Montreal Cup.

The William Doherty Annual Referee Achievement Award: This is presented to a Judo Ontario Referee who has shown significant advancement in their referee development over the past season. The recipient can be any active referee of any level and is selected by the JORC members. This year's recipient is Carline Young.

Over this past season, Carline has demonstrated her on-going desire to improve her officiating skills by refereeing events and attending various clinics both in and out of Ontario. At this past year's Edmonton International Judo Tournament, Carline was evaluated by the JC National Referee Committee and was promoted from JO Provincial A to JC National B skipping the National C level. Carline was also the one of three recipients of a JC bursary to assist with her expenses towards improving her officiating skills.

### Judo Canada Director to Ontario Report

#### SPORT DEVELOPMENT

The 2018/2019 National Circuit events were successfully delivered in 6 jurisdictions. A request to sanction a 7th event was received from the Province of Manitoba. If the request is approved, a minor adjustment to the tournament calendar is expected in the 2019/20 season.

The Canada Winter Games judo event was successfully conducted in Red Deer, AB. The new format (experimental age division; more than one athlete per P/T/weight division, etc.) of the event has proven successful and no changes to it are proposed for the 2023 edition.

Another successful edition of the Elite Open National Championships hosted at the TOHU. The 2020 edition will be hosted at the Centre Pierre Charbonneau in conjunction with the IBSA Pan Am Championships.

The 2019 Open National Championships moved to Edmonton and were hosted at the Van Vliet Centre of the University of Alberta. The number of entries in the Shiai decreased by 8% in comparison to the 2018 edition, which is not unexpected considering that the focus of many P/T in this season was the Canada Winter Games judo event.

#### NCCP

The Coaching Association of Canada have initiated a number of new initiatives and requirements that affect all sports organizations, and judo is no exception. The latest developments are:

The first cycle of the Professional Development requirement started on January 1, 2019, and a number of coaches found themselves in a "not renewed" status, which rendered them ineligible to coach and forced them to take Professional Development activities to re-establish their "certified" status.

- Several new online courses have been developed by the Coaching Association of Canada and other organizations. These are the easiest options to get the required Professional Development points and all are accessible via the LOCKER or the CAC Database.
- A new protocol has been developed for "Professional coaches" status offered by the CAC. Details are available at the CAC website.
- The CAC certified 5 Judo Master Coach Developers who are now able to train judo facilitators and evaluators, who in turn will be able to deliver the Assistant and Instructor courses and evaluations.
- The CAC certified 8 judo mentors, who are now able to deliver one-on-one NCCP training to potential future coaches.

Judo received the CAC approval of two new contexts in the NCCP program. As of the beginning of the new season (September 1, 2019), the LOCKER will feature the "Community Judo Coach" trained status, as well as the "Certified High Performance Coach" status. Details on these developments will be available in the 2019 NCCP policy update.

### Judo Canada Director to Ontario Report Continued

#### PARALYMPIC JUDO

The international Paralympic judo scene is changing very rapidly with the cooperation between IBSA Judo and the IJF. From having 3-4 international events annually until 2017. The international calendar now includes 4 sanctioned World Ranking events per year, plus 6 "developmental" events that do not offer World Ranking points. Further to this development, there is a further visible increase in quality of athletes entering the Paralympic Judo Stream, many of whom are successful international competitors in the able body judo world.

The Canadian Paralympic Team now has only two international level competitors. Priscilla Gagné won a historic World Championships bronze medal in 2018. She was the only B1 female athlete on the World Championships podium (all weight divisions).

Judo Canada continued to deliver a judo program at the school for blind kids in Longueuil. This project, however, will very unlikely result in recruitment of many potential Paralympic competitors for a variety of reasons.

The CEO of Judo Canada organized another initiative to be delivered to the Visually Impaired population in Montreal over the coming summer vacation period.

#### **GRADING & KATA COMMITTEE**

The committee examined and recommended seven individuals for High Dan grading. These individuals were recognized for this achievement in their provinces, as well as during the annual banquet in Edmonton.

- Hachidan: Jim Kojima, William Doherty, Mitch Kawasaki
- Shichidan: Yves Landry, Wayne Yamashita

Since the last AGM, there have been a number of events related to the development of kata in Canada. In August, there was a pre-world training clinic held in Montreal for the teams that were attending the World Championships in Cancun, Mexico. This inaugural event was also open to the membership and was well received.

In Cancun, an IJF Kata judge evaluation was conducted and four individuals were certified as IJF judges: Mohamed Hassani, Duncan Vignale, Gérald Poirier and June Takahashi. In addition to the strong performance of the Canadian team, we were also represented by four IJF judges: Hiroshi Nakamura, Gilles Lachaine, Yves Landry and Fred Blaney, all of whom judged both preliminaries and finals.

Since the last AGM, there have been two national kata judge evaluation events: one in Toronto and one in Moose Jaw, Saskatchewan. This program, which establishes a pathway for kata judges, has resulted in Canada having, by far, the most National, Pan-American, and IJF-level judges of all the countries in Pan-America. This leadership and expertise have been recognized by the PJC with the appointment of Hiroshi Nakamura and Gérald Poirier to the PJC Kata Commission. In addition, Daniel De Angelis has been appointed as the IJF Kata Commission Director.

### Judo Canada Director to Ontario Report Continued

#### **REFEREE COMMITTEE**

The referee committee has put their efforts in promoting female referees to national level. First, we added to our committee a subcommittee to help us on special occasions and special projects. Mrs. Diane Couture and Mr. Milton Good. This year, Mrs. Diane Couture associated herself with Mrs. Aartje Sheffield and Brian Fujimoto to organize a women seminar in Toronto, which was a real success. Diane also travelled to help many women with their refereeing skills toward succeeding in national evaluations. We are proud to say that this year, out of 19 referees promoted at different national levels, 8 were women. Congratulations to Diane, Aartje and Brian for that accomplishment.

In April 2018, we had 12 referees converted to Continental level. During the last year, we also had 17 referees representing Canada in 30 international events. In addition, 5 referees represented Canada in international referee and coach seminars. It is of the utmost importance to have Canadian referees in major events. The road to these invitations is usually the commencement of referees participating in international events.

#### GENDER EQUITY COMMITTEE

The Women Committee was renamed Gender Equity Committee. The committee was involved in several components.

#### First component: Referees

Diane Couture went to Brampton, in Ontario, to offer a referee clinic to a group of women. There were 3 women from Quebec and 21 from Ontario.

Last March, Diane Couture went to Edmonton as a mentor to several women who wanted to pass their referee evaluation. Judo Canada supported 3 referees from Quebec and 1 from Ontario.

#### Second Component: Training and Internships

In May 2018, Judo Canada hosted a U12&U14 girl's training camp with Carolyne Lepage, Alix Renaud-Roy, Émilie-Claude Leroux and Marie-Hélène Chisholm. During the break, Marie-Josée Morneau (1996 Olympian) gave a lecture. The camp was held at the National Training Center. 50 girls attended.

In December 2018, Judo Canada hosted a second U12&U14 girl's training camp with Carolyne Lepage, Émilie-Claude Leroux and Marie-Hélène Chisholm. During the break, Nathalie Gosselin (1996 Olympian) gave a lecture. The camp was held at the National Training Center. 50 girls attended.

Yuka Osumi did a female training camp tour in Canada:

- Prince Edward Island Jan. 2019
- New Brunswick Feb. 2019
- British Columbia Feb. 2019

On January 11, a lecture was held on "How to coach girls" for all the coaches who attended the Elite National Championships. A dozen coaches attended.

### Judo Canada Director to Ontario Report Continued

#### Third component: Promoting women's judo

The Committee made small tattoos to give out during the committee's activities. Cynthya Tan, a new committee member (promotion and media), is currently working on a new logo and t-shirt designs.

#### Fourth component: Coaching

In December 2018, Alix Renaud-Roy was selected to attend a coaching seminar in Japan. The seminar lasted a month.

#### Fifth Component: Training/Involvement/Others

In June 2018, Judo Canada was proudly hosting the first Women's Summit. A report was drafted by Martine Chanier (Management advisor). Numerous issues were discussed and several lectures offered, namely:

Sport'Aide with Guylaine Dumont and Sylvain Croteau, Psychosocial factors of Women in Sport by Chantal Daigle, Health and Nutrition for Women by Catherine Naulleau, and How to Make your Place in the World of Sport by Guylaine Demers.

#### **TOURNAMENT COMMITTEE REPORT**

The Judo Canada A Tournaments - Eastern Canadian Championships, Saskatchewan Open, Quebec Open, Ontario Open, Edmonton International and Pacific International – were all a success. This year, we also added the Eastern Canadian Open Kata Championships and the Western Canadian Championships to our A Tournaments circuit.

We went to Edmonton for the first time in May for the Canadian Open Judo Championships. Edmonton rose up to the challenge. This year, after the Canadian Open Championships in Edmonton, a session was offered with Christian Royer and Steve Horvath for anyone interested in the Judo Shiai tournament system.

We will host another Canada Cup this year, followed by the Grand Prix. Both events involve a huge amount of work from the office and volunteers. Everyone is invited to come help us make these 2 events a success and prove the world we are proud and able to host them.

#### COMMUUNICATION

The communication strategy is paying off. The reach of our social media platforms is still quickly growing: Facebook: 14,186 followers (+14%)

Instagram: 5,728 followers (+35%)

Twitter: 7,549 followers (+11%)

Webcast platform: judocanada.tv have reached over half a million viewers over the year.

Newsletter: now has now 13,489 recipients as expected with the introduction of the online database. Over the course of the last 18 months, 9 newsletters were published. The average rate of opening is 50%, compared to the industry's average of 21%.

#### MEMBERSHIP AND DATE BASE PROJECT

From March 31, 2018, to March 31, 2019, our membership went from 21,363 to 20,927, a decrease of 436 members. This decrease translated into a decrease of revenue of \$6,729 as more regular member decreased. This is a second year in a row that a decrease is noted.

Overall, we can conclude that the transition to online registration system was a success, but still a few areas requires improvement.

#### GOVERNANCE

It is the first year that the new Bylaws are in operation. A shift was noted on the Board of Director, with the resignation of Bianca Ockedahl and the nomination of Donna Hanson.

Due a recommendation from Sports Canada, the Regional Representative (Director) position on the board has now been removed from the bylaws and has now been replaced with 5 Director at Large positions elected by the membership. So the current Director of Ontario will be in the position until the 2020 Judo Canada Elections.

The Election in 2020 will be in September due to it being an Olympic year.

#### FINANCE

We are operating our national event financially profitable. It was also the case of our 2 international events hosted last year: The IBSA Pan Am and Canada Cup.

We have invested into a small property in Montreal, with the goal to host intern and short-term staff. This grow our investment and liberate some cash flow.

At the end of the fiscal year, we respected the budget and generated a benefit of \$103,564. Going into the most challenging year of our history in term of finance, this cushion is appreciated!

#### To the Members of Ontario Judo Black Belt Association

#### **Qualified Opinion**

We have audited the financial statements of Ontario Judo Black Belt Association (the "Association"), which comprise the statement of financial position as at March 31, 2019, and the statements of operations, changes in net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, except for the effects of the matter described in the Basis for Qualified Opinion paragraph, the accompanying financial statements present fairly, in all material respects, the financial position of Ontario Judo Black Belt Association as at March 31, 2019, and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

#### **Basis for Qualified Opinion**

In common with many non-profit organizations, the Association derives revenue from contributions, the completeness of which is not susceptible of satisfactory audit verification. Accordingly, our verification of these revenues was limited to the amounts recorded in the records of the Association. Therefore, we were not able to determine whether any adjustments might be necessary to revenues, excess of revenues over expenses, and cash flows from operations for the year ended March 31, 2019 and 2018, current assets as at March 31, 2019 and 2018, and the net assets as at April I and March 31 for both the 2019 and 2018 years.

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Association in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our gualified opinion.

#### Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Association's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Association or to cease operations or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Association's financial reporting process.

#### Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement whether due to fraud or error and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but it is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

# ONTARIO JUDO BLACK BELT ASSOCIATION ALSO KNOWN AS JUDO ONTARIO NOTES TO THE FINANCIAL STATEMENTS

#### MARCH 31, 2019

#### I. PURPOSE OF THE ASSOCIATION

Ontario Judo Black Belt Association ("the Association") is an Ontario corporation without share capital and for Canadian income tax purposes, qualifies as a not for profit organization which is exempt from income tax under the Income Tax Act. The purpose of the Association is to promote and develop amateur Judo in Ontario.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements were prepared in accordance with the Canadian accounting standards for not-for-profit organizations in Part III of the CPA Canada Handbook and include the following significant accounting policies:

#### **Revenue recognition**

The Association follows the deferral method of accounting for contributions and fundraising. Unrestricted contributions are recognized as revenue, when received or receivable, and when collection is reasonably estimated.

Revenue received which is related to the following fiscal year is deferred accordingly.

Revenue from registration fees is recognized proportionately over the fiscal year to which it relates.

Revenue from the sale of merchandise is recognized upon delivery.

Nevada revenues are recorded when boxes of tickets, for a specific license, are issued to ticket sales agents, and if the amount can be reasonably estimated and collectability is reasonably assured.

Government grants are recognized as revenue in the year in which the related expenses are incurred.

Participant fees are recognized as revenue when services are performed. Fees received in advance are recorded in fees collected in advance and recognized into revenue during the appropriate period.

#### **Contributed Services**

Certain services have been contributed to the Association to assist in its operations. Because of the difficulty of determining their fair value, contributed services are not recognized in the financial statements.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

#### Equipment

Equipment is recorded at cost less accumulated amortization. Amortization is provided on all assets on a straight line basis per annum, which is designed to charge the cost of assets to income over their estimated useful lives.

#### **Restricted Net Assets For Youth and Junior Programs**

Funds raised from Nevada ticket sales are restricted for youth and junior programs.

#### Use of Estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the period. Actual results could differ from those estimates. Estimates and assumptions are periodically reviewed and the effects of revisions are reflected in the financial statements in the period they are determined to be necessary. The areas requiring a significant estimate are the collectability of accounts receivable, accrued liabilities and amortization of equipment.

#### **Financial Instrument Measurement**

The Association initially measures its financial assets and liabilities at fair value. It subsequently measures all its financial assets and financial liabilities at amortized cost. Financial assets measured at amortized cost include cash and accounts receivable. Financial liabilities measured at amortized cost include accounts payable and accrued liabilities.

#### 5. FINANCIAL INSTRUMENTS

#### **Risk Management Policy**

The Association is exposed to various risks through its financial instruments. The following analysis provides a measure of the risks at the reporting date, March 31, 2019.

Liquidity risk

Liquidity risk is the risk of being unable to meet cash requirements or fund obligations as they come due. The Association manages its liquidity risk by constantly monitoring forecasted and actual cash flow and financial liability maturities.

Credit risk

The Association is exposed to credit risk with respect to accounts receivable. The Association assesses, on a continuous basis, accounts receivable on the basis of amounts it is virtually certain to receive.

Other risks

It is management's opinion that the Association is not exposed to significant foreign currency, interest rate or market risks arising from the financial instruments.

The extent of the Association's exposure to all risks did not change during the year.
